- The SUN Business Network (SBN) is the private sector branch of this movement, and aims to support businesses in growing the role they play in the nutrition
- In Zambia, the SUN Business Network is facilitated by WFP, with support from a number of donors

- Sharing general information about your organisation and its efforts to support nutrition
- (For food companies) Following responsible practices of infant feeding
- (For food companies) Not marketing any product to children under the age of 6 months
- (*For food companies*) Following appropriate marketing practices for children of 6 24 months of age, which includes positioning foods as a complement to continued breastfeeding to the age of 24 months or beyond

#### Principles of Engagement of the SUN Business Network Zambia:

- Members should act in line with a commitment to uphold the equity and rights of all women, men and their children
- Members should recognise the importance of moral and social action within a competitive nutrition market. Be advocates for the cause of improved nutrition in Zambia
- Members should support and respect the protection of internationally proclaimed human rights; and make sure that they are not complicit in human rights abuses
- Members should comply with UN guidance on health and nutrition, with a specific mention of the International Code on Marketing of Breast Milk Substitutes and World Health Assembly resolutions related to Maternal, Infant and Young Child Nutrition
- · Members should work against corruption in all its forms, including extortion and bribery
- Members should uphold the elimination of all forms of discrimination in respect of employment and occupation
